General

The Sequim Bay Yacht Club (SBYC), as Host, extends this invitation to participate in the 2002 Lido 14 Class Championship Regatta this coming August 11th through the 15th on Sequim Bay in Washington. Sequim Bay is located in the Northwest corner of Washington State on the Olympic Peninsula, approximately 50 nautical miles Northwest of Seattle as the crow flies and 20 miles South of the city of Victoria B.C., Canada. It was the site of the 1996 Championship Regatta and offers outstanding sailing conditions for small boats in sheltered waters.

Enclosed with this Notice of Race, you will find an official Registration Form and an official 2002 Lido 14 Class Championship Regatta Measurement Check List.

Rules

This regatta is governed by the 'rules' as defined in Racing Rules of Sailing 2001-2004 (RRS) and the rules of the Lido 14 International Class Association except as they are modified by this Notice of Race. Advertising shall be restricted to Category A per RRS Appendix 1 Regulation 20. In the event of conflict, the Sailing Instructions shall have precedence.

Divisions

This Regatta will be sailed as the Lido 14 International Division Class Championships. A Junior Division is not included in the event, however, there is no age restriction on competitors wishing to compete in this event.

Eligibility

The Class Championship Regatta is open to all 2001-2002 members of the Lido 14 International Class Association who meet the Association By-Law requirements for competing in the International Division Class Championship Regatta. As is required by Class By-Law Article XVII.3, competitors shall have actively and legally raced a Lido 14 sometime between 1958 and June 13th, 2002 (i.e. at least 60 days prior to the Class Championship Regatta) to be eligible for this Regatta. For Junior sailors, an interest in a Lido 14 is not required. This modifies the Class Bylaws.

Boat Launching & Storage

Launching facilities include a car launch ramp. No hoist is provided. The Port of Port Angeles has jurisdiction over the John Wayne Marina and its launching ramps. They normally charge a launch fee of \$7.25 per day however, at the time of printing of this Notice, the launch fee had been reportedly waived. If any Port fees still apply, they will be collected separately. Arrangements for wet storing boats at a marina dock will be made.

On site boat dry storage facilities will be provided free of charge.

Free local residential storage of boats and trailers will be provided for participants wishing to explore the Pacific Northwest after the regatta. For information contact Regatta Management.

Measurement

Unless otherwise arranged in advance with the Chief Measurer, boat measurement will not be provided at the regatta. Participants must check in at regatta headquarters during the times listed in the Schedule of Events to weigh the skipper, weigh the crew, weigh their ballast, present a valid and signed measurement certificate (or legible copy thereof), and present a completed Measurement Check List, which must be completed by your Fleet Measurer prior to the start of the Regatta. If you have measurement questions, contact your local fleet measurer first.

Unattached members and members belonging to fleets without a Fleet Measurer should contact the Chief Measurer for answers to measurement questions. The Chief Measurer will provide boat measurement to these members and then only by appointment. For measurement questions and appointments, contact the Chief Measurer at:

Sailing Instructions

Sailing instructions will be issued at the times of Registration / Check-In noted in the Schedule of Events.

Sailing Instructions will include, but are not limited to all information on flights to be sailed, courses, scoring, safety requirements, alternate penalties and mediation and protest procedures.

This regatta consists of two series: The Preliminary Series and the Final Series. The purpose of the Preliminary Series is to rank the competitors so that the top one-half may be assigned to the Gold Flight and the remainder to the Silver Flight. The precise methodology for ranking competitors and assigning them to flights will be disclosed in the Sailing Instructions. At the discretion of Regatta Management, the Gold and Silver Flights may be sailed together.

Trophies

Perpetual Trophies and Honor Awards will be presented as prescribed in the Lido 14 International Class Association Handbook and Class Roster.

Take home trophies will be awarded to the skipper and crew of the first ten (10) finishers in the Gold Flight and the skipper and crew of the first five (5) finishers in the Silver Flight.

Take home trophies will be awarded to the skipper and crew of the first two (2) all Junior teams to finish.

The assignment of teams for the Team Trophy will be based upon the finishing positions at the conclusion of the qualifying races. The sailing instructors will define team assignment more precisely.

All Trophies will be presented during the Awards Banquet to be held in the John Wayne Marina Banquet Hall. Dress code is Smart Casual.

Accommodations

Accommodations are specified in the Tourist and Accommodation Information Package, previously distributed, and the Sequim Website www.cityofsequim.com. Additional Accommodation and Tourist Information Packages are available on request by contacting Susan Sorensen, Publicity and Community Liaison Chair, as noted below. For those participants planning to camp at Sequim Bay State Park, there is a launching ramp at that facility and arrangements can be made for a towing service to John Wayne Marina and/or the starting line. Specific information on RV parking at John Wayne Marina will be provided in the Registration Packet.

Because John Wayne Marina is a public facility, we do not have the flexibility that we would have if it were a private club. The Port of Port Angeles, the owner and operator of the Marina, was very accommodating in allowing us special RV parking and boat launching privileges during the 1996 Class Championship Regatta. We will attempt to renew these privileges for 2002 and will publish Parking and Launching Guidelines in accordance with the Port's decision. We ask that you observe these guidelines during your visit to John Wayne Marina.

Annual Meeting

The Annual Meeting will be held in the John Wayne Marina Banquet Hall to conduct Official Class Association Business including the election of new Officers. A dinner will be served. Dress code is Casual.
