1. RULES

- 1.1 The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing.
- 1.2 The Organizing Authority (OA) is the Newport Harbor Yacht Club (NHYC).

2. ADVERTISING

Advertising will be restricted to Category A.

3. ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to Lehman 12(A and B Fleets), Lido 14(A and B Fleets), Harbor 20(A and B Fleets), Santana 30/30, Wavelength 24, Santana 20, Schock 35, and Schock 40 boats. Other interested One-Design classes may be invited to sail and are encouraged to contact the NHYC Race Director prior to March 1, 2006.
- 3.2 Skippers must be members of US Sailing or a recognized club under ISAF to be eligible to sail in this event.
- 3.3 Eligible boats may enter by completing the attached form and sending it, together with the required fee to the address provided on the form. Completed entry forms and entry fees (payable to NHYC), must be filed with NHYC on or before March 1, 2006, to avoid late penalties.

5. SAILING INSTRUCTIONS

Sailing Instructions will be available upon registration at NHYC.

6. RACING AREAS

6.1 Lehman 12, Lido 14, and Harbor 20 boats will race in the harbor north of the NHYC Main Dock.

6.2 Wavelength 24 boats will race in the harbor north of the NHYC Main Dock on Friday 3/3/06 and will race in the ocean off Newport Beach on 3/4/06- 3/5/06.

6.3 Santana 20, Santana 30/30, Schock 35, and Schock 40 boats will be racing in the ocean off Newport Beach.

7. THE COURSES

The courses for all classes will be windward -leeward type courses or any variation of a triangular or other course. A leeward gate may be used at the Race Committee's discretion.

8. SCORING

8.1 Two races are required to be completed to constitute a series.

8.2 When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.

8.3 When six (6) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9. RADIO COMMUNICATION

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

10. TROPHIES

Trophies will be awarded to class winners based on the number of entries on Sunday, March 5, 2006, as soon as possible after the last race.

11. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunctions with or prior to, during, or after the regatta.
